

task instruction

1. Purpose

- A. It is in defining the details for fulfilling the support conditions and conditions in connection with the school bus purchase.

2. Coverage

- A. This work directive applies to all matters required by the contracting party of the Singapore Korean International School for the purchase of school buses purchased by Singapore Korean International Schools. The items not included in this work order are the "Laws and Regulations on Contracts" .

- (1) Business name: Purchase school bus
- (2) Purpose: Student bus service
- (3) Delivery place: Singapore Korean International School
- (4) Purchase product and quantity: 1 school bus
- (5) Delivery time limit: Within 30 days from contract date

3. Contractor Obligations

- A. The Contracting Parties shall inspect and review the contract documents and other contract documents before the contract. The questions must be confirmed by the Singapore Korean International School, and the interpretation and related laws and regulations of the Singapore Korean International School.
- B. The Contracting Parties shall be responsible for all damages incurred in the performance of this work that are incurred by acts contrary to the relevant laws.

4. Warranty and Maintenance

- A. The warranty period shall be 3 years (or 100,000km) from the date of inspection, and the contracting party shall promptly perform maintenance and maintenance so that the operation can be maintained smoothly.
- B. The Contracting Parties shall take corrective measures by replacing parts or replacing new parts in accordance with the requirements of Singapore Korean International School in case of any defects in production even after the warranty period expires.

5. Delivery

- A. The Contracting Party shall deliver the designated school bus to the designated place of the Singapore Korean International School and submit the confirmation of delivery of the person in charge.
- B. Supply one piece according to the standard specification, but deliver it to the latest model.

6. Inspection

- A. After the delivery is completed, it should be inspected whether or not the delivered

vehicle is operated by function.

- B. When the same specifications as the purchase details in the specification are satisfied and there is no abnormality after the test, it is assumed that the delivery is completed.

7. Required Documents

- A. The contracting parties shall document and submit the instruction manual and the quality assurance certificate when delivering school buses.
- B. The contracting parties need to carry out technical examination, safety inspection, vehicle painting, etc. before the vehicle is shipped.

8. General Information

- A. Purchase of this vehicle should be made and delivered without violation of the current laws and regulations.
- B. Those who want to participate in the bid must fully understand all the items necessary for the bid including the task instructions, specifications and contract conditions, and respond to the bid. The bidder is responsible for failing to understand the bid.
- C. Vehicle, and other device operation methods and manuals.
- D. It is necessary to conduct driving operation and equipment manager training at delivery, and to check whether the equipment is operating normally or whether it is made optional.
- E. Upon delivery, all necessary documents for vehicle registration shall be submitted.
